BOARD CHAIR & CEO MESSAGE

Dear Friends,

We sincerely thank you for your generous support of Catholic Charities Hawai'i (CCH) and present a brief summary of how your help has benefited the communities we serve. Through the challenges of 2020, you continued to be by our side by donating, volunteering, and responding to the needs of our community.

It has truly been a transformative year for Catholic Charities Hawai'i as our team took on extraordinary challenges affecting struggling families and individuals. Our staff rose to these challenges in many ways, highlighted by the following:

- Throughout the pandemic our programs made vital adjustments to continue to address the needs of their service community. The safety of clients and staff were given high priority, as masks, sanitation, social distancing, telehealth appointments and other virtual engagements became the norm.
- Our Lanakila Multi-Purpose Senior Center continued to engage **1,500 seniors** via phone and started virtual online classes (including yoga, ukulele, cooking, Zoom tutorials, hula, tai chi, and computer classes) to keep center members connected.
- Our CCH Housing Programs team assisted the state with COVID-19 Rent and Mortgage Relief services - **distributing nearly \$38 million to over 9,000 households statewide** in a three-month period. The team also designed an online application system and automated payment system to carry out this important program.
- Our Information, Intake and Referral Helpline experienced **an increase from 600-700 calls per month to approximately 500 calls per week** as our Helpline was flooded with pandemic-related calls.

We kicked off 2021 with a new Rent & Mediation Program, which is currently distributing **over six million dollars** to households statewide. With this second rent relief program, we are reminded of how high the needs are in the community as our economy slowly tries to make its way towards recovery.

Thank you for your commitment and support in our efforts to make an impact in the lives of so many through our over 40 programs and services. Helping each other overcome life's challenges is what community is all about. Mahalo for being an important member of our Catholic Charities community.
