**Dr. Terry Barclay** is a fellowship trained neuropsychologist with research and clinical expertise in aging and dementia. He received his doctorate in clinical psychology from Michigan State University with residency training in geropsychology at the West Los Angeles VA Medical Center. He went on to complete the NIMH postdoctoral program in neuropsychology at the David Geffen School of Medicine at UCLA where his research focused on the cognitive, behavioral, and psychological changes associated with normal aging, Alzheimer's disease, and other dementias.

He is currently the Director of Neuropsychology at HealthPartners and Regions Hospital in St. Paul and an Adjunct Associate Professor of Neurology at the University of Minnesota. He specializes in neurodegenerative disease and timely detection of cognitive impairment in the geriatric population. He has led the development of a range of evidence and consensus-based tools for healthcare providers that have been adopted and utilized by systems in Minnesota and around the country. Dr. Barclay also works with federal agencies and a wide variety of healthcare organizations to develop professional education curricula and instructional videos that are used to train physicians and other healthcare providers at major universities and healthcare systems throughout the U.S.

Dr. Barclay is the past Co-Chair of the Quality Healthcare and Detection Leadership Group of Minnesota's ACT on Alzheimer's, is a dementia consultant for the Minnesota Department of Human Services, served as Clinical Director of Minnesota's statewide program for dementia caregivers called Family Memory Care, and is the past Chair of the Medical and Scientific Advisory Council for the Alzheimer's Association Minnesota-North Dakota.
